

**BROWN COUNTY ART GALLERY FOUNDATION
PATRON ART COMPETITION RULES
SPRING SHOW – MAY 14 – 22, 2011**

**Open to all supporting patron members of the Brown County Art Gallery Foundation,
except those artist members of the Brown County Art Gallery Association, Inc.
Without age limitations (minimum dues \$25 per year)**

This is a non-juried show with all submitted art displayed (unless the artwork is not suitable for children's viewing). There is a \$7.00 hanging fee per painting for up to two submissions. All art forms other than photography will be accepted. We encourage submission of fresh original works each year.

There will be two divisions in the show. One division for professional artists (those artists who either teach, have sold paintings or have been juried into three (3) shows), and one division for amateur artists. The professional division will receive ribbon awards only. The amateur division will receive cash and ribbon awards.

The hanging fee (less ribbon cost) is redistributed as Winner Awards in the amateur division. Honorable mention winners and all winners in the professional division will receive appropriate ribbons only. Additional financial sponsorship donations contribute to increasing cash awards in the amateur division.

Submissions may be "not for sale" (NFS) or they may be priced by the artist for sale during the exhibit. Any work sold during the show will entail a 35% commission.

Bring works to the gallery Monday & Tuesday, May 9 & 10, 2011. Entries will be hung in the North and South galleries. Hanging works may not exceed 40" in any direction and must be framed and wired for hanging. No saw-tooth or hook hole hangers accepted. Watercolor and pastel works are to be under glass with non-exposed edges. All oil, acrylic or other media works must be dry. Sculptures submitted are to be able to sit securely on a display stand. Top heavy items must be properly supported. **All entries are to be picked up Monday - Wednesday, May 23-25, 2011.**

Artist must fill out tags. Include name, title, medium and price. Place one tag on the back and front of the work to facilitate the printing of display cards. Usual gallery security measures will prevail. The show is not specially insured against theft or damage. By submission of artwork to the show, the artist agrees to permit photographing of their entry, should it be incidentally reproduced as part of any publicity photo associated with the show.

Judges for the show are selected from among South Central Indiana professional artists, art dealers or museum curators. Unless special arrangements are made before hand, all works are to be picked up on the days noted above. Otherwise gallery vault storage fees will apply.

Any concerns over issues not specifically spelled out in the above entry rules will be resolved at the discretion of the gallery manager.
